1. Agenda

2. Minutes

MOTION: Kevin Zahara moved to accept the June 8, 2011 Arts Centre for Edson Society minutes as presented. Motion carried.

3. Reports:

a. Town of Edson Presentation, June 21: Peter reported the presentation went very well as the Edson Town Council then voted unanimously in support the concept (attaching the theatre to the Rec Complex) in principle.

b. Yellowhead County Council Presentation, August 23: Dave reported the presentation went well with a lot of positive discussion from the Council.

c. Special Meeting, September 14: Peter reported that ACES developed a brief plan to display the architectural drawings, along with a FAQ sheet and a survey at the Edson Centennial celebrations, September 21 to 24. Andrea said she would be able to use survey monkey to post the survey online.

4. Releasing Architectural Drawings & Cost Estimates:

a. Display: ACES finalized the survey form that will accompany the architectural drawings. The group then decided to make arrangements to display the drawings at numerous locations around Edson:

- November 21 to 28: Holy Redeemer Catholic Jr/Sr High School

These locations will need to be confirmed. ACES members will report back. ACES will then try touring County areas in early 2012 to receive feedback from County residents.

b. Meeting with MLA Robin Campbell: It was decided to wait until after the expected provincial election this fall to meet with Mr. Campbell to update him on our progress.

c. Meeting with MP Rob Merrifield: ACES will try to set up a meeting as soon as possible with Mr. Merrifield to update him on our progress.

d. Meeting with GYPSD & Living Waters: ACES will table this item to the October meeting.

e. Letter to Edson Town Council: ACES will send a letter to Edson Town Council requesting funding be included in the 2012 budget so that the next phase of architectural drawings and research can be completed.

MOTION: Dave Michie moved that the Arts Centre for Edson Society send a letter to the Edson Town Council requesting funding be included in the 2012 budget to cover the cost of the next phase of architectural drawings. Motion carried.

5. Business Plan

a. Draft: ACES reviewed the document and made adjustments. Peter and Kevin will set up a meeting with the Town's Finance Manager to go over the Operational Costs section. ACES may need a special meeting in early October to approve the final document before both Edson Town Council and Yellowhead County Council begin their budgeting phase.

b. Marketing Plan Grant: Doug was not present to speak about this item.
