If the society ever folds, the complex operation will revert to the town of Edson. \$300,000 of the town's operating capital goes to the facility for maintenance and operations.
- b. It was suggested by a councillor that we consider joining with A.H. Daikin when they rebuild. This brings to light that there are other options available though none come without their challenges.
